The Deceased

The decedent was **Georgia [REDACTED]** (never married). She died on 21 April 2019 in Pequannock, Morris, New Jersey (See Document 2). Her parents were Peter [REDACTED] and Frieda [REDACTED] (See Document 3) who were married 18 June 1908 in Manhattan, NY (See Document 5). Georgia was subsequently born on 18 February 1916 (See Documents 1, 2, & 3) in Staten Island, Richmond, NY. She was their third of four children (See Documents 8, 9, and 10).

Parents of Deceased

The decedent's father, **Peter [REDACTED]**, was born on 10 December 1875 in Carrickmacross, County, Monaghan, Ireland, the son of Francis and Elizabeth [REDACTED] (See Documents, 4, 5, and 6). Peter married Freida [REDACTED] (See Documents 5 and 6) on 18 June 1908 in Manhattan, NY. He died on 9 April 1945 in Richmond, NY (See Documents 6 and 7). Peter and Freida had four children:

The decedent's mother, **Freida [REDACTED]**, was born on 18 April 1886 in Jersey City, Hudson, New Jersey, the daughter of John and Marie [REDACTED] (See Documents 5, 85, and 86). The State of New Jersey has no birth record for Freida [REDACTED] (See Document 84). Freida died on 18 February 1937 in Staten Island, Richmond, NY (See Document 85).

Siblings of Deceased

Ruth [REDACTED] – Ruth [REDACTED] was born on 10 February 1910 in Manhattan, NY, the first child of Peter [REDACTED] and Freida [REDACTED] (See Document 8). Ruth was a premature birth and died the same day she was born, 10 February 1910 (See Document 9). She only lived for 12 hours.

Virginia [REDACTED] – Virginia [REDACTED] was born on 20 June 1913 in Manhattan, New York, the second child of Peter [REDACTED] and Freida [REDACTED] (See Documents 10, 11, and 12). Virginia never married and had no descendants (See Documents 11 and 12). She died on 22 March 2001 in Staten Island, New York (See Documents 11 and 12).

Decedent's First Cousins, Once Removed (Children of First Cousins)

NOTE – It is believed that many of these first cousins, once removed are still living. At the request of the client, no contact was made with any living individuals in the family. Information to complete the many lines of descent will require contacting some of the living individuals to learn information about other living relatives of the decedent. The list of living individuals will be incomplete until this portion of research is finished.

Elizabeth [REDACTED] was born 1 September 1936 in New York City, NY, the daughter of Thomas and Elizabeth [REDACTED] (See Documents 152 and 156). Elizabeth's marriage information is unknown. It is believed that she is married to Lawrence [REDACTED], and that she is still living. All vital records pertaining to her are restricted.

Mary [REDACTED] was born about 1938 in New York (See Document 152), the daughter of Thomas and Elizabeth [REDACTED]. No other information is known about Mary [REDACTED]. Contact will need to be made with her sister, Elizabeth, to learn vital details about Mary [REDACTED].

Maureen [REDACTED] was born 5 January 1941 in Richmond, NY, the daughter of Frank [REDACTED] and Mary [REDACTED] (See Documents 40, 75, and 77). She married Martin [REDACTED], but the marriage information is unknown. Martin and Maureen were found in the Minnesota Divorce Index in 1976 (See Document 157). Maureen died on 9 August 2011, possible in Nassau, NY (See Documents 76 and 77).

Michael [REDACTED] is believed to have been born 10 March 1942 in Brooklyn, NY, but his birth is unconfirmed. No other information about Michael is known. Contact with one of his siblings is required to learn more about him. His brother, Andrew, died in 2017, and Michael is listed in his obituary as surviving his brother.

Andrew [REDACTED] was born 7 October 1944 in Brooklyn, NY, the son of Frank [REDACTED] and Mary [REDACTED] (See Documents 40, 77, 78, and 79). He married Denise [REDACTED], but the marriage details are unknown (See Document 79). Andrew died on 26 August 2017 (See Document 79).

Kathleen [REDACTED] was born 30 September 1948 in New York City, NY, the daughter of Frank [REDACTED] and Mary [REDACTED] (See Documents 40, 77, and 79). She married Daniel [REDACTED] in 1972 in Queens, NY (See Document 81). Kathleen is still living.

Angela [REDACTED] is a daughter of Frank [REDACTED] and Mary [REDACTED] (See Documents 40, 77, and 79). She married David [REDACTED]. Angela is still living.

Summary:

The decedent, Georgia [REDACTED], never married. She had three siblings – two sisters and a brother. All three siblings are deceased. Neither of her sisters ever married, and her brother married, but he had no children. Both of her parents are deceased. All four of her grandparents are deceased. Of her twelve aunts/uncles (siblings of her parents), all are deceased or presumed to be deceased. All were born before 1900. Two have no date of death – one living his entire life in Ireland, and no date of death found; the other dying in childhood and having no death record.

All eight of Georgia’s great-grandparents are either deceased or presumed to be deceased, as they were all born prior to 1850. Many of their identities are unknown because they lived their entire lives in either Ireland or Germany, and neither Irish nor German research was performed on this project.

Georgia's first cousins (children of Georgia's Aunts and Uncles) total twenty-four in number. Twenty-two are deceased or presumed to be deceased. The two remaining first cousins are a brother and sister – Francis and Mary [REDACTED] of Ireland. Irish research is required to learn if they are living or deceased.

Georgia's great-aunts/uncles are undetermined. All lines of the family at this point require either Irish or German research in order for the lines to be complete. This research has not been performed.

Georgia has forty-six known first cousins, once removed. The total number of first cousins, once removed is unknown without completing the Irish and German research. Of the forty-six known, seven are known to be deceased. Thirty-nine have either contact information or a sibling who can be contacted for information about them.
